**Sales Agreement**

**Deep Creek Mini Aussiedoodles/breeder requires a deposit of \$300.00 to hold a puppy. The deposit is non-refundable and will only be refunded in the event the puppy does not pass its vet health check. It is the buyer's responsibility to pay in full the balance due by the time the puppy is 6 weeks of age. The breeder can make transportation arrangements but the buyer will incur any additional charges. Once the puppy is picked up, delivered or shipped the sale is final and covered by our 1-year guarantee. The Breeder can not be held responsible for the health and well being of the puppy once it is placed in the hands of a transporter, nanny, airline etc.**

**Puppies are ready for new homes at the age of 8 weeks. Puppies kept after this time will incur an additional charge per day at the Buyers expense.**

**This puppy is sold with the understanding that he/she will not be used for breeding purposes and will be spayed/neutered at the time recommended by the Buyer's Vet. Buyer agrees to spay/neuter the puppy. Failure to do so or if the said puppy produces a litter, the buyer is subject to a fine of up to \$5000 payable to Deep Creek Mini Aussiedoodles.**

**Breeder guarantees the puppy to be healthy at the time of pick up, and free of any known genetic conditions for a period of one year. If a veterinarian diagnoses the puppy with any genetic defect, the breeder will require copies of the exam and medical exam notes as well as any labs or diagnostic testing done to confirm said diagnosis. Buyer must provide diagnosis, documentation, veterinarians certification, address, phone number within 2 business days to the Breeder. Failure to do so will void the health guarantee. Injuries or negligence on part of the owner/buyer is not covered under the breeders one year health guarantee. Do Not expose your puppy to non-vaccinated dogs, areas where other dogs defecate such as rest stops, dog parks etc. Your puppy is not fully vaccinated and exposure to such areas can cause your puppy to become ill.**

**The puppy will have been wormed and current on age appropriate vaccines. The breeder does not guarantee against Giardia and or Coccidia. These are common protozoans that are often dormant in puppies and are brought out by stress such as transport or acclimating to a new home. These conditions as well as worms are easily treated and the responsibility of the new owner. The buyer will be provided with documentation of wormer and vaccinations at pick up.**

**The puppy has been examined by a licensed veterinarian prior to the sale. The results of the exam will be shared with the buyer.**

**The buyer agrees to have the puppy seen by a veterinarian within 72 hours after taking possession of the puppy at the Buyers expense. Breeder has taken every care and precaution with breeding, rearing and overall welfare of the puppy/dog and believed to be in good health, and is sold in good faith. The breeder makes no warranty however as to the health, disposition, size of the dog outside of what is listed in the health guarantee and medical chart.**

**Failure to comply with vaccinations, worming and heart worm prevention will void the health guarantee.**

The buyer agrees to provide the puppy with proper housing, diet, vet care, and socialization, for the entire life of the puppy. The buyer agrees to provide appropriate vet care including

vaccinations and heartworm prevention. The buyer under no circumstances should place the puppy into a pet store, rescue, or shelter.
